## **Chifeng Jilong Gold Mining Co., Ltd.**

### **Announcement on the Release of Pledged Equity by the Controlling Shareholder**

The Board of Directors and all Directors of the Company warrant that this announcement does not contain any false records, misleading statements or major omissions, and they will bear legal liabilities for the authenticity, accuracy and completeness of its contents.

#### **Important**

As at 29<sup>th</sup> December 2025, Ms. Li Jinyang, the controlling shareholder of Chifeng Jilong Gold Mining Co., Ltd. (hereinafter as "**the Company**") and the party acting in concert, Yantai Hanfeng Zhongxing Management Consulting Ltd. (hereinafter as "**Hanfeng Zhongxing**") holds 190, 410, 595 and 51,515,151 equity shares of the Company, accounting for 10.02% and 2.71% of the Company's total equity share capital. After the release of pledged stock equity described herein, the controlling shareholder and the party acting in concert have accumulatively pledged a total of 52,900,000 shares and 9,177,680 shares respectively, accounting for 27.78% and 17.82% of their shareholding in the Company, representing 2.78% and 0.48% of the Company's total share capital.

On Dec 29, 2025, the Company received a notice from the controlling shareholder, Ms. Li Jinyang, on the completion of the release of pledged equity for portion of Chifeng Gold shares under her with the details set forth as follows.

#### **I. Details of the share pledge release**

On December 25, 2024, Ms. Li Jinyang obtained the securities pledge registration certificate issued by China Securities Depository and Clearing Corporation for pledging 34,000,000 shares of the Company she held to Tibet Trust. Recently, Ms. Li Jinyang completed the procedures to release the pledge on the aforementioned shares and obtained the notification of release of securities pledge registration on December 29, 2025.
